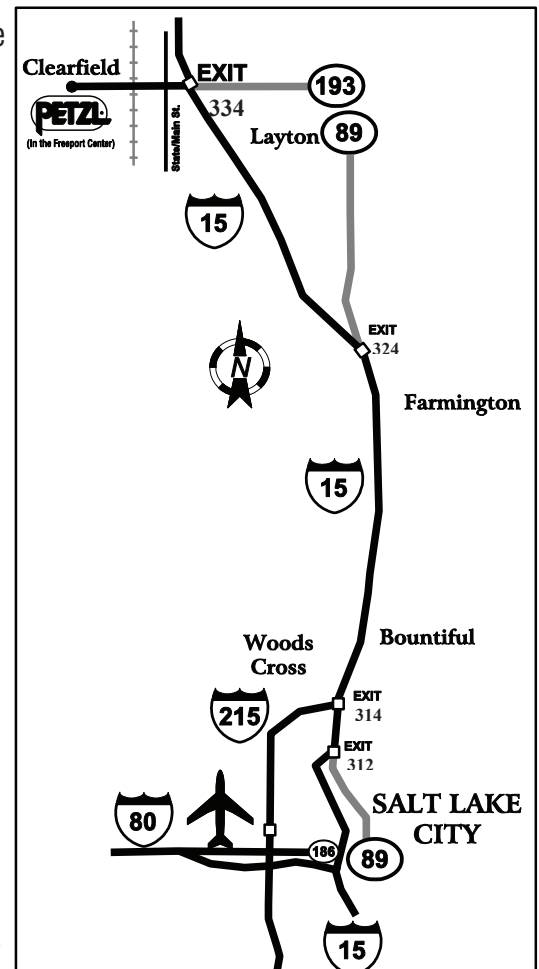

ACKNOWLEDGMENT AND ASSUMPTION OF RISKS, RELEASE OF LIABILITY AND INDEMNITY AGREEMENT

PLEASE READ CAREFULLY BEFORE SIGNING.

THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.

In consideration for Petzl America, and all associated parent companies, subsidiaries, and related entities and their directors, officers, agents, employees, or volunteers (collectively, "Petzl") allowing me to participate in Petzl activities, including but not limited to gear demonstrations, workshops, clinics, training, use of the bouldering wall at Petzl, training center, indoor and outdoor climbing, caving, canyoneering, borrowing equipment from Petzl, or other activities sponsored by Petzl, whether at a Petzl facility or elsewhere (collectively "Petzl Activities"), the undersigned hereby understands, acknowledges, and agrees as follows:

1. I am over the age of 18 and capable of understanding the terms of this AGREEMENT and the risks associated with Petzl activities.
2. I recognize and understand that there are risks, hazards and danger in Petzl Activities and participation could result in injuries of all kinds, including **SERIOUS INJURY OR DEATH**. I understand that my participation in Petzl Activities is voluntary and that I have the right to terminate my participation at any time. I acknowledge that I am capable of participating in Petzl Activities and do not suffer from any health problems that would inhibit my participation. The risks involved in Petzl Activities include, but are not limited to: hazards in traveling to the location of the activity, falling, collision with objects, people or structures, being struck by other participants or objects, loose rock, equipment failure even if equipment is properly used, the actions or negligence of other participants or instructors, harm due to exposure to the elements, the aggravation of pre-existing conditions, and other risks inherent in the activities.
3. Understanding these risks, I EXPRESSLY ASSUME ALL RISKS ASSOCIATED WITH THE PETZL ACTIVITIES, inherent and otherwise, and whether or not described above. I further agree to observe and comply with all rules and regulations prescribed by Petzl for the Petzl Activities and to properly use all Petzl equipment. I understand it is my responsibility to know how to properly use the equipment and if I have any questions, I will make sure my questions are answered.
4. I, for myself, heirs, assigns, representatives and next of kin, WAIVE AND RELEASE Petzl from any claims, liability, or causes of action arising out of my participation in the Petzl Activities, including claims of negligence. I also agree to INDEMNIFY Petzl from any claim, liability, or cause of action by third parties arising out of my participation in Petzl Activities.
5. I understand that to use the bouldering wall at Petzl I must: (1) sign this agreement; (2) complete the instructional program provided by Petzl; and (3) read and abide by the Rules and Regulations for use of the bouldering wall.
6. In the event of an accident, I authorize Petzl to stabilize, obtain medical care for, or transport me to a medical facility if, in the opinion of Petzl, medical care is needed and I am unable to make such decisions for myself. I agree to pay all costs associated with such actions on the part of Petzl, and to INDEMNIFY and hold Petzl harmless from any consequences resulting from such care.

7. Petzl is hereby authorized to take photos and video of me in connection to my participation in Petzl Activities and to use my name and likeness, without compensation, for marketing and other promotional purposes.
8. In any action where one party either seeks to enforce its rights under this Agreement or seeks a declaration of any rights or obligations under this Agreement, the prevailing party shall be awarded its reasonable attorney fees, and costs and expenses incurred.
9. I understand that this agreement shall continue in effect and remain in force in perpetuity from the date it is executed, and covers my participation in all Petzl Activities.
10. If any provision of this agreement is held invalid, the remaining provisions shall continue in full force and effect.
11. This agreement shall be construed in accordance with the laws of the State of Utah, and any dispute arising under this agreement and I hereby submit to the exclusive jurisdiction of the courts of Davis County, Utah.
