"NAO +" CONTEST RULES

1. SPONSORING AND ORGANIZING COMPANY

The Petzl Distribution ("Petzl") company, a limited liability company, with a capital stock of 688,440 Euros, registered with the Grenoble, France company registry under registration number 388 381 642, and located at Zone Industrielle, 105A 38920 Crolles Cedex, France,

is organizing a free Contest, with no purchase necessary, entitled "NAO +."

2. WHO MAY ENTER

This Contest is open to all individuals with an Internet connection and a valid email address, with the exception of those persons residing in Italy and/or who have Italian citizenship, as well as Petzl employees, members of their families, and all other persons with a direct or indirect connection to the design, creation, or implementation of this Contest, as well as members of their immediate families.

3. TERMS

The Contest will be held on the Petzl website.

The Contest begins on October 3th, 2016, and ends on October 30, 2016.

The term "Entrant" denotes all members of a household residing at the same address and bearing the same last name. An Entrant is only authorized to participate once during the entire Contest. A maximum of one prize will be awarded per Entrant.

Each Entrant is to be identified by the following: first and last name, age, mailing address, email address, and telephone number, all provided when entering the Contest. In the event of a dispute, only the Petzl participation lists are binding.

4. CONTEST RULES

Enter and participate in the Contest via the http://www.petzl.com website.

Entrants must fill out the Contest registration form, read and accept these official rules.

5. DESIGNATING THE WINNERS

The winners will be designated via random drawing every Monday morning at 10:00 AM CET at the Petzl Distribution company headquarters located at Zone Industrielle, 105A 38920 Crolles Cidex, France. The list of Participants will be reset to zero after each draw. The random drawings will be conducted automatically using a computer algorithm (a random mathematical calculation used to designate the winner). There will be five (5) designated winners per week.

Any incorrect contact information (erroneous address or one that proves to be falsified during verification) will not be taken into consideration. If this occurs, the designated winner will forfeit their prize.

Winners will be contacted by email. Petzl will not be held liable in the event that one or more winners are unreachable.

6. GENERAL INFORMATION

Simply entering the contest signifies full acceptance, without limit or reservation, of the present Contest rules. Petzl will make the final decision regarding any dispute.

To be admissible, any dispute must be submitted within one month after the official contest end date.

Entrants will not be allowed to contest Petzl's decision if an entry is nullified.

In the event of a technical malfunction preventing one or more Entrants from participating, or altering the information sent by one or more Entrants, for whatever reason, Petzl is not liable for any costs or damages incurred by any of the Entrants.
